- (a) Clause 25 in Form No. 2911(i) & 2911(ii) is hereby deleted as per Govt. Order No. 558/SPW dated 13.05.2011 of P.W.D. Govt. of West Bengal.
- (b) BANK DRAFT / PAY ORDER OF ANY NATIONALISED BANK IN FAVOUR OF THE EXECUTIVE ENGINEER, HOUSING CONSTRUCTION DIVISION NO.-V, PAYABLE AT DURGAPUR WILL BE ACCEPTED AS 'EARNEST MONEY'.

RECEIPT OF THE BANK (COUNTER PART) FOR THE PURCHASING OF BANK DRAFT / PAY ORDER WILL NOT BE ACCEPTED AS EARNEST MONEY AND IN THAT CASE THE TENDER PAPER WILL FORMALLY BE TREATED AS 'INFORMAL'.

- (c) Enlisted Contractors of P.W.D having fixed permanent Security deposit with P.W.D. in respect of their class of enlistment as per rule 230, P.W.D. code vol.1 are not exempted in depositing earnest money for work under Housing deptt.
- (d) In case, the intending Tenderer is not able to attend in person as mentioned in sl. no. 9(a) his authorised representative having "POWER OF ATTORNEY" (REGISTERED) can submit the application for the issue of Tender papers and in that case the Photo Identity Card (e.g. Voter I.D./ Driving Licence / Passport etc. of the authorised person to be placed in front of the official on demand.
- (e) Work order and completion Certificate of last 3(Three) years will be treated as credential. Application for purchase of tender paper without having supporting documents as mentioned will be treated as incomplete and summarily cancelled.
- (f) In the event of the Tender, being submitted by a firm consisting of several partners, a declaration from the chief Executive Director of the firm informing the name and signature of all the partners of the firm and also indicating the name of partner/partners with signature having authority to sign Tender papers as well as in application for purchasing Tender papers.
- (g) In case of co-operative societies no authorisation will be accepted for the submission of Application for the purchasing of tender papers as well as for the execution for work.
- (h) The intending Tenderer or his authorised representative (as mentioned in 'C') may have to put signature in the application if necessary (on demand) in front of the officials of this office at the time of submission of the application for the purchasing of tender paper.
- (i) The signature of the Intending Tenderer or his authorised representative should tally in all the documents – right from the application, tender, Formal Tender paper, acceptance of measurements and also in the receipt during payment.
- (j) Engineers 'Co-operative Societies' may also apply for sanitary and Plumbing (S&P) Works, provided at least one of the members of the said Society holds 'PLUMBING LICENSE'.
- (k) In case of Engineers Co-operative Society, their present status should be satisfied with submission of the following documents on demand :-
  - (i) Upto date 'NO-OBJECTION' Certificate from the Registrar/Deputy or Assistant Registrar of Co-operative Societies.
  - (ii) Bye-law of Co-operative Society duly approved by the Assistant Registrar of Co-operatives.
  - (iii) Supporting valid documents showing area of operative.
  - (iv) Name, address and signature of the present Board of director.
  - (v) Minutes of Last Annual Meeting and Audit report of the same to the concerned Authorities of Co-operative Societies.
- (l) No Tender papers will be sold on the date of dropping of tender.
- (m) All other terms and conditions are incorporated in special Terms and conditions.

Intending tenderers will have to submit Xerox copies of PAN of I.TAX, S.TAX, I.T., Return (SARAL) current year and P.Tax clearance certificate along with enlistment order, Credentials, Byelaws, Registration validity certificate, Audit report, VAT Registration number / Certificate must be produced along with other relevant documents for Engineers Co-opt. Societies, at least one member of the society holds Plumbing license (in case of S&P works only), Original documents of the same are to be shown for verification at the time of application for permission of the tender.

The Executive Engineer, Housing Constn. Division No.-V reserve the right to refuse issuing tender papers to any applicant without assigning any reasons for it and the decision of the Executive Engineer, Housing constn. Div.No.-V in this respect will be the final. The Executive Engineer, Housing Constn.Div.No.-V reserves right to reject any or all the tenders & applications so received without assigning any reason.

Intending Tenderers should arrange to procure tenders well in advance to avoid difficulties due to non-availability at Head Qtr's Officers issuing tender papers.

### SPECIAL TERMS & CONDITIONS

Recovery of 1%(one percent) CESS on the total construction cost in accordance with the building & other construction workers (REGULATION EMPLOYMENT & CONDITION SERVICE) Act' 1996 will be implement.

No arbitration will be entertained for work as per G.O. no. 235/1, (10-HI-2C-5/86) dated 16.03.1991 of PWD, Govt. West Bengal.

Last 3(Three) years credentials will only be treated as valid completion Certificate / Payment Certificate issued by any Govt. concern in each work only be considered as credential.

Sinkage / shrinkage will be deducted from the supplied materials i.e. earth, morrum, stone metal, sand, cinder, lime, rubbish, jhama bats, jhama metals etc. etc as per PW(Rds.) specification and Govt. circulars. All other norms will be maintained as per PWD Schedule.
