Circular

It is felt necessary to frame a guideline regarding procedure for making online application and drawing up FORM A and FORM 1 for formation and registration of Association of Apartment Owners under the West Bengal Apartment Ownership Act, 1972 (the Act) so that anyone who intends to form an Association of Apartment Owners under the said Act may find it helpful.

Now, therefore a Guideline is issued hereby in supersession of all guidelines issued earlier as annexure of this circular for the aforesaid purposes.

Competent Authority under the West Bengal Apartment Ownership Act, 1972

Guideline for making online application and drawing up Form A and Form 1 for formation and registration of Association of Apartment Owners.

For formation of an Association of Apartment Owners and getting the said Association registered under the **West Bengal Apartment Ownership Act, 1972** (the said Act) an application needs to be made **online** in the portal in two phases. There will be an **offline hearing** in between two phases during the examination of Form A by the Competent Authority. The details of which are discussed herein below.

For making an application for **formation** and **registration** of **Association of Apartment Owners** one has to visit the portal **https://edistrict.wb.gov.in** and register himself/herself at that portal. Thereafter he/she shall login to the portal and will find four menus-(1) District, (2) Development Authority, (3) Development Corporation and (4) Department. He / She has to choose the Menu **'Department'**. Under the 'Department' menu he/she will find Housing Department. Clicking on the 'Housing Department' five (5) services will be found. He / She has to choose the service **Registration of Apartment Owners Association.** The eligibility criteria for submitting Form A and the Fees details shall be found there.

Fees Details are stated below:

Above Rs. 1 Crore up to Rs. 5 Crore	Rs, 5,000/-

Above Rs. 5 Crore	Rs 10,000/-

A print out of the instruction may be taken, if required, by clicking the 'Print" button. Thereafter he/she has to click the "Apply" button and proceed filing up data in the system related to the Housing Estate for which Association of Apartment Owners will be formed. After filing the required data, he/she has to upload copy of building Plan, Site Plan, Completion Certificate, PAN card/Voter Card of the declarants (5 in Number) and receipt of Form E (5 in Number) in the system.

He/she has to make **online payment of requisite fees** which the system will prompt him/her. After making payment and completing the application in all respect he has to submit the same to the Competent Authority. A unique 16-digit **Application Index Number (AIN)** shall be generated starting with **012185.**

The Competent Authority on receiving the application in the system will examine the same and will approve the online application, if found it correct, and immediately an autogenerated information of such approval of application be sent to him/her through s.m.s. and a **Notice for Hearing** under **section 10A(2)** of the West Bengal Apartment Ownership Act, 1972 will be sent to him/her through the system.

If during the examination of the online application it is found that the same is incorrect, any comment made by Competent Authority regarding the application will be updated in the system in real-time and auto-generated information of such comment will be received by the applicant through s.m.s and the system also.

During the hearing the applicant shall submit **duly affirmed Form A** to the Competent Authority. **Documents and papers** to be submitted along with Form A during the time of hearing are stated herein below:

- (i) Forwarding letter addressed to the Competent Authority under the West Bengal Apartment Ownership Act, 1972 stating the AIN No. of the application and the date of approval of the application in the system. A format of the same is enclosed herewith.
- (ii) A summary Sheet of the declaration. A format of the same is enclosed herewith.
- (iii) Declaration in Form A in original executed and solemnly affirmed before a Magistrate or a Notary in a Non-Judicial Stamp Paper of Rs. 10 (ten) along with the annexure from A to E. A format of the same is enclosed herewith.

Annexure A-Authenticated copies (that is signed by some declarants or signed by the notary) of building plan;

Annexure B- Authenticated copies (that is signed by some declarants or signed by the notary) of Site plan;

Annexure C- Copy of relevant Completion certificate; **Annexure D collectively**- Copies of Voter card/Pan Card of the declarants for identification;

Annexure E- Copies of receipt of letter in Form-E served to all the apartment owners.

If declaration in Form A is made by a constituted attorney duly authorized by executing an instrument of Power of Attorney, then an affidavit of the Attorney to be enclosed along with the Form A. A format of the same is enclosed herewith.

Two declarants of Form A (i.e., two apartment owners) shall also appear before the Competent Authority and go through **duly affirmed Form A** once again and check whether all the data stated in Form A and all the copy of documents annexed with Form A are correct or not. The two declarants shall immediately submit a letter to the Competent Authority stating correctness or otherwise of the Form A so submitted.

Disposal of Form A by the Competent Authority:

If after examination of the Form A it is found that the property concerned comes within the purview of the Act and the declaration is in order the Competent Authority will accept the Form A by making an endorsement of such acceptance on the body of Form A. A Digitally Signed Acceptance Order (DSAO) will be generated in the system which the applicant may download from the portal. Thereafter immediately the Competent Authority shall return the Form A duly endorsed as "Accepted" on the body of the Form A to the applicant. If the Form A is found not in order it will be "Rejected" and the Rejected Form A will be returned to the applicant immediately. No hardcopy of Accepted or Rejected Form A is retained in the office of the Competent Authority.

How to file copy of Form-1 and Accepted Form A in the edistrict system

Form 1 is application for registration of Association formed under clause (2) of Bye-law 3 of the West Bengal Apartment Ownership Bye-laws, 1974. Within **forty-five days** from the date of acceptance of Form A or within such further period as the Competent Authority may allow, the apartment owners of each property, owned by four or more apartment owners, shall in a general meeting **form an Association** under some **specific name and style**, and the apartment owner presiding over such meeting shall immediately communicate the formation of such an Association along with the names of the members thereof, in **Form No. 1** to the Competent Authority. Form 1 under bye-law 3(2) is to be drawn up in statutory format. **Format of Form 1**, **Resolution of the General Meeting and the Attendance Sheet are enclosed herewith**.

The names of all apartment owners irrespective of whether he/she has made declaration in Form a or not shall be stated in Form 1 as per the provisions of bye-law 3 of the West Bengal Apartment Ownership Bye-Laws, 1974. Where an apartment is owned by more than one person any one person of their choice will be member of that Association from that particular apartment.

A coloured scanned PDF copy of Form 1 shall be uploaded in the portal along with coloured scanned PDF copy of **Resolution of the General Meeting** and the **Attendance Sheet** of such meeting by the applicant.

At the same time the applicant shall upload a coloured scanned PDF of **Accepted Form A** along with a copy of Forwarding letter, Summary Sheet, coloured scanned PDF of Affidavit of the Attorney if Form a is executed through Power of Attorney, a self-signed identification document of the Attorney, letter of the declarants to the Competent Authority on the date of hearing, self-signed identification documents of both the declarants.

There are some fields in the system related to Form 1 which are required to be filled up by the applicant before submitting the same in the portal.

<u>Issuance of Certificate of Registration of an Association of Apartment Owners</u>

The competent Authority shall approve Form-1 if it is drawn up in accordance with law and thereafter a **Digitally Signed Certificate of Registration (DSCR)** of the association with the date of formation of the Association mentioned therein shall be generated. The applicant may download the same from the portal.

 - (ii) that each apartment owner, present or future, shall be entitled to an undivided interest in the common areas and facilities in the percentage expressed in the Declaration and appurtenant to such apartment;
 - (iii) that the common areas and facilities, general or restricted, shall remain undivided and that no owner shall bring any action for partition or division thereof so long as the property remains submitted to the provisions of the said Act;
 - (iv) that the percentage of the undivided interest in the general or restricted common areas and facilities, as expressed in the Declaration, shall not be altered except with the consent of all the apartment owners expressed in the an amended Declaration duly executed and registered as provided in the said Act;
 - (v) that during the period the property remains subject to the said Act, no encumbrance of any nature shall be created against

the property, though such an encumbrance may be created only against each apartment and the percentage of undivided interest in the common areas and facilities appurtenant to such apartment, in the same manner as in relation to any other separate parcel of property subject to individual ownership;

(vi) that the percentage of the undivided interest in the common areas and facilities shall not be separated from the apartment to which it appertains and shall be deemed to be conveyed or encumbered with the apartment even though such interest is not expressly mentioned in the conveyance or other instrument;

(vii) that no apartment owner shall do anything which would be prejudicial to the soundness and safety of the property or reduce the value thereof or impair any easement or hereditament or shall add any material structure or excavated any additional basement or cellar;

(ix) that for the proper and effective administration of the property and for the due maintenance, repair and replacement of the common areas and facilities the apartment owners shall strictly comply with the provisions of the said Act and the byelaws made thereunder and shall pay their share or common expenses as assessed by the Association of Apartment Owners, and that the failure to comply with any such requirement shall be a ground for action for damages or for other relief or reliefs at the instance of the Manager or the Board of Managers on behalf of the Association of Apartment Owners or in a proper case, by an aggrieved apartment owner.
