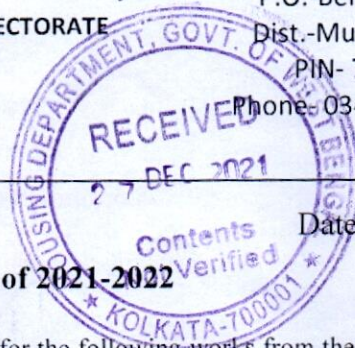

The tender documents & other relevant particulars (if any) may be seen by the intending tenderers in the office of the undersigned on any working day between 11.30 am to 4.30 pm. Intending tenderers personally or by person holding power of attorney should Valid Trade License (Sanitary and plumbing work should be clearly mentioned in case of S&P work) , Professional Tax clearance Certificate along with current challan, PAN card with IT Return last 03 (three) years, GST registration certificate along with current challan & Completion Certificate issued by the Executive Engineer or Equivalent or competent authority will be treated as valid credential [Work order and Payment Certificate will not be treated as credential]

For partnership firm Registration Certificate, Registered partnership deed and registered power of attorney must be submitted with the application and other relevant documents.

The Engineers Co-operative Societies as well as Regd. Labour Co-operative Societies will have to produce ARCS Bye-Laws, current audit report along with other relevant documents

All papers and documents in Original as well as Xerox copy duly self attested will have to produce along with application. Self Attested Xerox copy will be retained along with application.

The Assistant Engineer, Berhampore Sub Division, Housing Directorate preserve all the rights for cancellation of any application without showing any reason after scrutiny of the application.

All materials such as cement, steel are to be procured at his own cost. Quality of material should be maintained as per relevant B.I.S. Code with necessary test report. Authenticated evidence for purchase of Cement & Steel (Reputed brand as approved by the Engineer-in-Charge) is to be submitted along with challan and Test Certificate. In the event of further testing opted by the Engineer-in-Charge, then such testing from any Government approved Testing Laboratory shall have to be conducted by the agency at their own cost.

Contractor shall have to comply with the provisions of (a) the contract labour (Regulation Abolition) Act. 1970 (b) Apprentice Act. 1961 and (c) minimum wages Act. 1948 (d) The West Bengal Building & other Construction Works Act if applicable or any other laws relating thereto and the rules made and order issued there under from time to time.

No Tender paper will be issued on the date of receipt of Tender.

Conditional tender will not be accepted and no escalation of rates would be allowed.

The rate quoted in figure & words shall clearly mentioned.

Necessary GST, Income tax and other necessary deduction will be charged as per Govt. rule.

The CESS @ 1.0 % (one percent) of the cost of construction works will be deducted from the bill of successful agency.

No arbitration will be allowed for the work as per provision for making arbitration vide clause 25 in WBF No. 2911(ii)


Additional performance security @ 10% of the tendered amount shall be obtained from the successful bidder if the accepted bid value is 80% or less of the estimated amount put to tender. Additional performance security shall be submitted in form of Bank Guarantee from any nationalized Bank before issuance of work order. This is in reference to the G.O. on. 4608-F(Y) Dt. 18.07.2018 of Additional Chief Secretary, Finance Department, Govt. of West Bengal.

Details of N.I.T. may be seen from the Notice Board of the Assistant Engineer, Berhampore Sub-Division, Housing Dte., the Executive Engineer, Nadia Division, Housing Dte., Krishnagar and the Assistant Engineer, Kalyani Sub-Division, Housing Dte. & during working hours in working days except holidays.

All tenderers are requested to be present personally during opening of tenders positively. If necessary, instant bid may be conducted immediately after opening of tenders to lower down rates and in no cases his/their absence will stand against holding the same.

N.B. – In case of any unavoidable circumstances occurred on the aforesaid dates the next working day will be treated as scheduled / prescribed for the same purpose.
