2. Both Technical document and Financial Bid are to be submitted in technical (Statutory & Non- Statutory) and financial folder Concurrently duly digitally signed in the website <http://wbtennders.gov.in>
3. The Technical document and Financial Bid submitted online on or before **17.06.2016** upto **4.00 p.m.**
4. The **FINANCIAL OFFER** of the prospective tenderer will be considered only if the **TECHNICAL Document** of the tenderer found qualified by the Executive Engineer, Housing Construction Division No.III. The decision of the Executive Engineer, Housing Construction Division No.III will be final and absolute in this respect. The both list of Qualified Bidders will be displayed in the website and also in the Notice Board of the office of the Executive Engineer, Housing Construction Division No.III, on the scheduled date and time.

5. **Eligibility criteria for participation in the tender-**

- i) The prospective bidders shall have satisfactorily completed **as a prime agency** during the last 3 (three) years from the date of issue of this Notice at least one work of similar nature of Government work & having a magnitude of 40% (forty percent) of the amount put to tender. [Non statutory Documents]  
**N.B. :- Completion certificate should contain a) Name of work , (b) Name of Client, (c) Amount put to tender, (d) Schedule month and year of commencement and completion as per work order (e) actual month and year of completion.**
- ii) The prospective bidders shall have in their full time engagement experienced technical personnel, the minimum being one Civil Engineering Diploma (Authenticated documents in respect of qualification and engagement shall be furnished for Technical Evaluation.) [Non statutory Documents]
- iii) Valid updating status & renewal of enlistment of contract Enlisted contractor of SE PC-I/II & Eastern Circle PWD Govt. of West Bengal for water proofing treatment of roof by bituminous felt etc. PWD (W.B), which has been issued to concerned contractor from P.W.D., Govt. of West Bengal, Pan card of Income Tax , copy of last I.T. Return, Sales Tax challan / Sales Tax , Professional Tax clearance certificate , VAT registration certificate, Trade Lisence, with updated VAT return which should be valid upto the date of opening of tender and credentials document (alongwith postal address, present phone number, fax no. of authority concerned who has issued such credentials) alongwith authenticated documents regarding working capital & declaration regarding abandoned/recessin of any contract during last 3 (three) years to be submitted through e-filing [Non statutory Documents].
- iv) **The working capital shall not be less than 15% (Fifteen percent)** of the amount put to tender and out of which minimum 10% shall be of applicant's own resource. Proper & authentic documents to be submitted through e-filing (alongwith supported up-to-date audited balance sheet). Evidence of access to or availability of credit facilities should be certified by the any commercial Bank [Non statutory Documents].
- v) Declaration regarding Structure and Organization duly digitally signed by the applicant to be submitted alongwith application.
- vi) In case of Registered Unemployed Engineers' Co-operative Societies documents of credentials showing satisfactory completion of a single work in P.W.D. Of Government of West Bengal of value not less than 40% of the Estimated Cost of the work applied for should be documented through e-filing. Audited balance Sheet showing accounts up to previous year and 'Certificate of Registration' and 'Certificate for Validity of Registration' from the respective Assistant Registrar of Co-operative Societies, Bye Law, Professional Tax Deposit Challan / Professional Tax Clearance Certificate, PAN Card, eligible list of Registered Unemployed Engineers' Co-operative Societies /



Registered Labour Co-operative Societies issued by the concerned Assistant Registrar of Co-operative Societies showing the name of their Society must be documented through e-filling. Also in case of Registered Unemployed Engineers' Co-operative Societies, documents in satisfying the following criteria are required to be documented through e-filling:-

- a) The Society consists of at least 10(ten) members of which at least 60% should hold Degree or Diploma in any branch in Engineering as per Memo No. 44-A/4M-11/2002 dt. 09.01.2004 of Deputy Secretary-III, P.W.D.. Privilege will be allowed as per G.O. No. 378(9)-A/PW/O/10C- 17/05 dt. 31-05-2005 P.W.D. Accounts Branch by Deputy Secretary-III including necessary documents in support of the statement and along with other supporting papers. (Non-Statutory documents)
- b) At least one member of the society holds plumbing license (in case of S & P works only)
- c) Above society must be submitted earnest money as mentioned in this e-NIT as per G.O.
- d) Above Society shall be allowed to participate in the work mentioned in this e-NIT as per G.O.
- vii) **Joint venture will not be allowed to participate in the above e-NIT.**
- viii) Where there is a discrepancy between the unit rate & the line item total resulting from multiplying the unit rate by the quantity, the unit rate quoted shall govern.
- ix) Prevailing safety norms has to be followed so that LTI (Loss of time due to injury) is zero.

6. No mobilization /secured advance will be allowed.

- 7. Agencies shall have to arrange land for erection of Plant & Machineries, storing of materials, labour shed, laboratory etc. at their own cost and responsibility.
- 8. All materials required for the proposed scheme as mentioned in this e\_NIT including Cement and Steel, shall be of specified grade and approved brand in conformity with relevant code of practice (latest revision) and manufacture accordingly and shall be procured and supplied by the agency at their own cost including all taxes. Authenticated evidence for purchase of cement and steel are to be submitted along with challan and test certificates. In the event of further testing opted by the Engineer-in-charge, then such testing from any Govt. approved Testing Laboratory shall have to be conducted by the Agency at their own cost.
- 9. Recovery of 1% cess on construction cost in accordance with the buildings and other construction worker's (Regulation of Employment & conditions of service) Act. 1996 will be implemented in this Tender.
- 10. In connection with the work, **Arbitration** will not be allowed. **The Clause No. 25 of 2911(ii) is to be considered as deleted clause vide gazzatte notification no 558/SPW-13th December, 2011.**
- 11. **Bids shall remain valid** for a period not less than 180 (One hundred eighty) days after the dead line date for Financial Bid submission. Bid valid for a shorter period shall be rejected by the Executive Engineer, Housing Construction Division No. III as non-responsive.
- 12. The prospective bidders shall have own the required plant & machinery. No lease Agreement or other arrangement will be acceptable. Conclusive proof of ownership for each plant & piece of machinery in working condition shall have to be submitted through e-filling [Non - Statutory Documents].
- 13. The prospective bidders shall be capable to establish field testing laboratory equipped with requisite instruments and technical staff so that if the work is finally awarded, he may establish such laboratory in the work site. Test of materials from outside recognized laboratory may be done, if required, at the discretion of the Engineer-in-charge. The cost for such testing will be borne by the agencies.

4. The intending bidders should clearly understand that whatever may be the outcome of the present invitation of bids, no cost of bidding is reimbursable from the department.
15. In case of inadvertent typographical mistake in the bill of quantity, the same will be treated to be corrected as to confirm with the prevailing relevant schedule of rates of PWD for South Western Circle or as per Technically sanctioned estimate.
16. The outside contractor should denote clearly in the application that the applicant is not enlisted contractor of PWD in any case.
17. No fixed Security Deposit will be allowed.
18. No Price Adjustment in respect of certain construction material (i.e. cement components, steel components etc.) will be considered.
19. The Tender evaluation committee will have sole discretion to decide eligibility of the contractor on the basis of e-filing documents and reserves the right to refuse any explanation to contractors found ineligible after scrutiny.
20. Running payment for the work may be made to the executing agency as per availability of fund.



21. The Agency will be liable to maintain the work at working portion at the appropriate service level to the satisfaction of the Engineer-in-Charge at his own cost for a period as per prevailing Govt. rule from the date of completion of the work. If any defect/damage is found during the period as mentioned above contractor shall make the same good at his own cost expense to the specification at par with instant project work. Failure to do so, penal action against the Agency will be imposed by the Department as deem fit. The Agency will have to quote his rate considering the above aspect.



22. All Bidders are requested to present in the 'Office of the EE, HCD NO.III', during opening the financial bid Executive Engineer, Housing Construction Division No. III, may call **Open Bid/Sealed Bid** after opening of the said bid to obtain the suitable rate further, if it is required. No objections in this respect will be entertained raised by any Bidder who will present during opening of bid, or from any Bidder who will absent at the time of opening of Financial Bid. No informal tenderer will be entertained in the Bid further.
23. Site of work and necessary drawings may be handed over to the agency phase wise. No claim in this regards will be entertained.
24. **Earnest Money** : Earnest money of lowest bidder @ 2% of the tendered amount must be submitted in favour of Executive Engineer, Housing Construction Division No. III in the form of Bank Drafts or Pay Order of any Nationalised Bank (N.S.C. & K.V.P. will not be accepted as Earnest money with the Tender) at the time of formal agreement as per Order No. 1592-F (Y) dated 20.03.2014. Amount of Earnest Money have mentioned in attached sheet of this NIT.
- Balance earnest money if required will have to be submitted alongwith submission of Tender documents for formal agreement.**
25. The Bidder, at his own responsibility and risk is encouraged to visit and examine the site of works and its Surroundings and obtain all information's that may be necessary for preparing the Bid and entering into a contract for the work as mentioned in the Notice Inviting Tender, before submitting offer with full satisfaction, the cost of visiting the site shall be at his own expense.
26. The intending Bidders shall clearly understand that whatever may be the outcome of the present invitation of Bids, no cost of Bidding shall be reimbursable by the Department. The Executive Engineer, Housing Construction Division No.III reserves the right to reject any application for purchasing Bid Documents and to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have incurred by any Tenderer at the stage of Bidding.
27. **Prospective applicants are advised to note carefully the minimum qualification criteria as mentioned in 'Instructions to Bidders' before tendering the bids.**
28. **Conditional/ Incomplete tender will not be accepted.**
29. The intending tenderers are required to quote the rate **on line**.
30. Contractor shall have to comply with the provisions of (a) the contract labour (Regulation Abolition) Act. 1970 (b) Apprentice Act. 1961 and (c) minimum wages Act. 1948 of the notification thereof or any other laws relating there to and the rules made and order issued there under from time to time.
31. **Guiding schedule of rates** – P.W.D. Schedule of rates for Eastern Circle with effect from 01.08.2010 for both Building, Sanitary & Plumbing works along with up to date corrigenda & agenda to be applicable on the date of issue of the e-NIT.
32. During the scrutiny, if it come to the notice to tender inviting authority that the credential or any other paper found incorrect/ manufactured/ fabricated, that bidder would not allowed to participate in the tender and that application will be out rightly rejected without any prejudice.  
The Executive Engineer, Housing Construction Division No.III reserves the right to cancel the N.I.T. due to unavoidable circumstances and no claim in this respect will be entertained.
33. In case if there be any objection regarding prequalifying the Agency that should be lodged to the Executive Engineer, Housing Construction Division No.III within 2 days from the date of publication of list of qualified agencies and beyond that time schedule no objection will be entertained by the Executive Engineer, Housing Construction Division No.III.

34. Before issuance of the **WORK ORDER**, the tender inviting authority may verify the credential and other documents of the lowest tenderer if necessary. After verification if it is found that the documents submitted by the lowest tenderer is either manufactured or false in that case work order will not be issued in favour of the said Tenderer under any circumstances.
35. If any discrepancy arises between two similar clauses on different notification, the clause as stated in later notification will supersede former one in following sequence.
- i) Form No. 2911(ii).
  - ii) e-NIT
  - iii) Special terms & conditions.
  - iv) Technical Bid.
  - v) Financial Bid
36. The prospective tenderers or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 3 (three) years. Such abandonment or rescission will be considered as disqualification towards eligibility
37. **Qualification criteria.**
- The tender inviting & Accepting Authority will determine the eligibility of each bidder, the bidders shall have to meet all the minimum regarding.
- a) *Financial Capacity.*
  - b) *Technical Capability comprising of personnel & equipment capability.*
  - c) *Experience/Credential*
- The eligibility of a bidder will be ascertained on the basis of the digitally signed documents in support of the minimum criteria as mentioned in a, b, c above. If any document submitted by a bidder is either manufacture or false, in such cases the eligibility of the bidder/ tenderer will be out rightly rejected at any stage without any prejudice .

SECTION – A

*1. General guidance for e-Tendering*

instructions/ Guidelines for tenders for electronic submission of the tenders online have been annexed for assisting the contractors to participate in e-Tendering.

1. Registration of Contractor

Any contractor willing to take part in the process of e-Tendering will have to be enrolled & registered with the Government e-Procurement system; through logging on to <https://etender.wb.nic.in> (the web portal of public works department) the contractor is to click on the link for e-Tendering site as given on the web portal.

2. Digital Signature certificate (DSC)

Each contractor is required to obtain a class-II or Class-III Digital Signature Certificate (DSC) for submission of tenders, from the approved service provider of the National Information's Centre(NIC) on payment of requisite amount details are available at the Web Site stated in Clause-2 of Guideline to Bidder DSC is given as a USB e- Token.

3. The contractor can search & download NIT & Tender Documents electronically from computer once he logs on to the website mentioned in Clause 2 using the Digital Signature Certificate. This is the only mode of collection of Tender Documents.

4. Participation in more than one work

A prospective bidder shall be allowed to participate in the job either in the capacity of individual or as a partner of a firm.

A prospective bidder (including his participation in partnership) shall be allowed to participate more than single road /building work as mentioned in the list of schemes.

5. Submission of Tenders.

General process of submission, Tenders are to be submitted through online to the website stated in Cl. 2 in two folders at a time for each work, one in Technical Proposal & the other is Financial Proposal before the prescribed date & time using the Digital Signature Certificate (DSC) the documents are to be uploaded virus scanned copy duly Digitally Signed. The documents will get encrypted (transformed into non readable formats).

A. Technical proposal

The Technical proposal should contain scanned copies of the following in two covers (folders).

**A-1.** Statutory Cover/ Technical file Containing

- i. Demand Draft/ bankers Cheque towards earnest money(EMD) as prescribed in the NIT against each of the serial of work in favour of the Executive Engineer, Housing Construction Division No. III.
- ii. Tender form No. 2911(ii) & NIT(Properly upload the same Digitally Signed). In case quoting any rate in 2911(ii) the tender liable to summarily rejected).
- iii. Declaration by the tenderer.

- Opening of Technical proposal :- Technical proposals will be opened by the Executive Engineer, Housing Construction Division No. III, and his authorized representative electronically from the web site stated using their Digital Signature Certificate.
- Intending tenderers may remain present if they so desire.
- Cover(folder) statutory documents(vide Cl. No. 5.A-1) should be open first & if found in order, cover(Folder) for non statutory documents (vide Cl. No. - 5.A-2) will be opened. If there is any deficiency in the statutory documents the tender will summarily be rejected.
- Decrypted (transformed in to readable formats) documents of the non statutory cover will be downloaded & handed over to the Executive Engineer, Housing Construction Division No. III.

Pursuant to scrutiny & decision of the Executive Engineer, Housing Construction Division No. III the summary list of eligible tenders & the serial number of work for which their proposal will be considered will be uploaded in the web portals.

- vii. While evaluation the Executive Engineer, Housing Construction Division No. III may summon of the tenders & seek clarification / information or additional documents or original hard copy of any of the documents already submitted & if these are not produced within the stipulated time frame, their proposals will be liable for rejection.

**viii. Opening & evaluation of Tender :-**

If any contractor is exempted from payment of EMD, copy of relevant Government Order needs to be furnished.

**B. Financial proposal**

- i) The financial proposal should contain the following documents in one cover (folder) i.e. Bill of quantities (BOQ) the contractor is to quote the rate (Presenting Above/ Below/ At per) online through computer in the space marked for quoting rate in the BOQ.
- ii) Only downloaded copies of the above documents are to be uploaded virus scanned & Digitally Signed by the contractor.

**6. Penalty for suppression / distortion of facts**

If any tenderer fails to produce the original hard copies of the documents (especially Completion Certificates and audited balance sheets), or any other documents on demand of the Executive Engineer, Housing Construction Division No. III within a specified time frame or if any deviation is detected in the hard copies from the uploaded soft copies or if there is any suppression, the tenderer will be suspended from participating in the tenders on e-Tender platform for a 3 (Three) years. In addition, his user ID will be deactivated and Earnest Money Deposit will stand forfeited. Besides, the P.W. Directorate may take appropriate legal action against such defaulting tenderer.




