Tax, work order with credentials (at least 40%) for last 5 years along with payment certificate and work completion certificate showing the name of work, tender No. date of commencement and completion, bill value etc. by the appropriate authority. All papers and documents in original as well as Xerox copy duly attested will be produced with application. Cumulative/ single payment certificate will not be counted as credentials. Attested Xerox copy will be retained with the application for further



course of action. The contractor personally or his authorized representative (should bear the proof of identity) should be present during submission of application and all the N.I.T related activity.


Tender document will be issued to the eligible contractor/ agency for participation in the NIT by the undersigned. The EMD will be in form of D.D./P.O of any nationalized bank will be enclosed (In original) with the tender at the time of dropping of tender. It may noted that no NSC/KVP will not be accepted as Earnest Money. The tenderer should clearly quote the rate in percentage in the space provided in the tender form and the EMD will be of exact amount as intended by the tender inviting authority. During opening, if found any sort of discrepancy the authority reserves the right to make decision of his own.

The Engineers' Co-Opp. Societies as well as registered Labour Co-Opp. Societies will have to produce A.R.C.S. issued BY -LAWS, Current Audit Reports, Credentials for last 05 years along with payment certificate and work completion certificate showing name of work, tender No. date of commencement and completion, bill value etc. as intended by the verifying authority, list of office bearers holding of public license by at least one no. of the said societies in case of participation in tender related S & P work vide F.D.G.O.-1341F dated. 21.02.2001 and H.D.S-IIIW.B. No. 1350 (7)-A/4M-37-2002 dated. 15.11.2002 and other relevant papers in original attested Xerox copy along with their application for seeking permission to participate in tender. Attested copies of documents produced during application will be retained by the Executive Engineer, Kolkata South I Division, Housing Directorate. The Executive Engineer, Kolkata South-I Division, Housing Directorate reserve all the rights of cancellation of any application without showing any reason after scrutiny of the application.

The successful tenderer will have to produce valid upto date GST clearance certificate in original on receipt of work-order from this end within the specified time positively if not produced earlier. No tender documents will be issued on the last date of receipt of tender. Tender dropped without E.M.D. will be rejected.

Intending tenderer should arrange to procure tender paper well in advance to avoid difficulties due to non-availability of HEAD QUARTERS of the officer issuing tender papers. In terms of F.D.S.G.O. No. 5895-F dated 11.09.2006 and C.E/H.D.'s Memo No. 1635(4)/HD Dt. 10.10.2006 Cess upto 1% from the contractor's bill shall be deducted for W.B. Building and other construction workers, Well fare Board. No arbitration will be allowed for the work as per provision for making arbitration

N.B.-In any case of any unavoidable circumstances occurred on the aforesaid dates the next working days will be treated as schedule/prescribe date for the same purpose.




