## NOTIFICATION

The following decisions have been taken by the Estate Directorate (on concurrence and approval from Housing Department) regarding distribution of work of the Public Rental Housing Estates situated outside of Kolkata Municipal Corporation as per Gazette Notification No. 576-H6 to 585-H-6 dated 16/10/2020 as a matter of general policy.

  - a) Receiving and processing of applications for fresh allotment of vacant flats.
  - b) Giving possession to the allottees.
  - c) Collecting Rent (through <a href="www.wbhousing.gov.in/">www.wbhousing.gov.in/</a> erent via GRIPS) and solving rent related problems like online mobile no. registration of the tenants, updating of the rent etc. under the supervision of the Estate Manager, Estate Directorate.
- (4) Audit matters and maintaining the establishment of the deployed employees are to be cone by the Estate Manager, Estate Directorate & exofficio Deputy Secretary, Housing Department.
- (5) Making new policies regarding these Housing Estates will be done by the Estate Manager, Estate Directorate following the approval of the Housing Department.
