- 5) A bidder should have to deposit requisite earnest money as stated above in the shape of Bank Draft at any Nationalized bank drawn in favor of the Executive Engineer, Malda Division, Housing Directorate. Payable at Karnajora, Raiganj.
- 6) The undersigned reserves the right to sell the articles in excess or less quantity than the quantity mentioned for which no complain will be entertained.
- 7) If necessary, the undersigned may not refund the earnest money to the bidders before the disposal of the aforesaid item.
- 8) All the bidder may remain present at the time of opening of the bidder and to participate in the bid, if call from just after the opening the bids. Anybody remaining absent will forfeit his right to participate and the bid that may be held will be final.
- 9) The successful bidder shall have to deposit in the shape of Bank Draft at any Nationalized bank drawn in favor of the Executive Engineer, Malda Division, Housing Directorate. Payable at Karnajora, Raiganj, the entire cost of the materials at the accepted rate within 7(seven) days from the date of acceptance of the bid otherwise his bid may be cancelled and earnest money deposited may stand forfeited.
- 10) The successful bidder will have to lift the materials (unsorted stack-yard) as is and where is basis.
- 11) After receipt of full amount (i.e. the cost of materials at the accepted rate) within the specified time, the successful bidder shall be asked to remove the materials from the relevant store room at his own arrangement and cost within the specified days from the date of issue of the lifting order, failing which lifting order issued to him, may be withdrawn and failing the amount deposited including earnest money may be forfeited to the Govt.
- 12) The successful bidder shall have to arrange at his own cost for carriage from the department store room including necessary lifting (including uprooting, if any), loading unloading, cutting and all sorts of head-load as necessary.
- 13) The earnest money deposited will be refunded to the bidder, after full lifting of materials from the stack-yard.
- 14) Condition etc. of G.I. Sheet, tank, pipe, P.V.C tank & all other items to be auctioned may be seen/ inspected by the intending quotation bidder before hand after contacting concerned Assistant Engineer, Junior Engineer; nothing will be heard tenable in this respect after offering of rates.
