We would like to bring to your kind attention that in the above mentioned tender you have given site wise deployment details which is not matching with the existing number of staff that are engaged in the sites.

We have identified the differences as follows:-

1. <u>Plumber plus Helper</u>:- Existing contract is having 39 numbers but this tender is showing 36 numbers. <u>Reduced by 3 numbers.</u>

2. <u>Sweeper</u>:- Existing contract is having 136 numbers but this tender is showing 129 numbers. <u>Reduced by 7 numbers.</u>

3. <u>Security:-</u> Existing contract is having 195 numbers but this tender is showing 189 numbers. <u>Reduced by 6 numbers.</u>

4. <u>Electrician:</u>- Same like existing contract. No deviation.

5. <u>Carpenter:</u>- Existing contract is having 3 numbers but this tender is showing 1 numbers. <u>Reduced by 2 numbers.</u>

6. <u>Carpenter Helper:</u>- Existing contract is having 3 numbers but this tender is showing 1 numbers. <u>Reduced by 2 numbers.</u>
