**ORDER**

***(1) All instruments relating to the Declaration or any amendment thereto referred to in section 10 or the instrument referred to in sub-section (3) of section 4 shall be deemed to be instruments compulsorily registrable within the meaning of clause (b) of sub-section (1) of section 17 of the Registration Act, 1908.”***

He/She is further requested to take steps so that Form 1 is submitted before the undersigned in accordance with clause (2) of bye-law 3 of the West Bengal Apartment Ownership Bye-Laws, 1974 for issuance of Certificate of Registration under this Act in favour of the proposed Association of Apartment Owners.
