

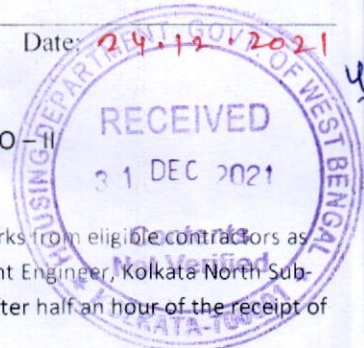



No arbitration will be allowed for the work as per provision for making arbitration vide clause 25 in W.B.F. No.2911 (ii).




