- 8. The validity of contract will be for 12 (Twelve) Months from the date of issue of the work-order.
- 9. Earnest Money: Earnest money only must be submitted (In favour of Executive Engineer, Kolkata New Town Construction Division-II, Housing Directorate) in the form of ONLINE ECS/NEFT THROUGH ICICI BANK GATEWAY PORTAL. Amount of Earnest Money have been mentioned in attached sheet of this NIT. This clause is also applicable for all categories of applicants as per GO 1110-F, dt. 10/02/2006 of Spl. Sec., F-D. Balance earnest money if required will have to be submitted along with submission of quotation documents for formal agreement for successful Quotationer.

- 12. The intending quotationer/bidder should clearly understand that whatever may be the outcome of the present e-NIQ no cost of bidding shall be reimbursable by the department. - 14. The intending quotationers are required to quote the rate online only.

(i) The intending Quotationer should produce credentials of a similar nature of completed work as a prime agency of the minimum value of 30% (Thirty Percent) of the estimated amount per year basis (Refer page No-7, Annexure-A) put to tender during 5 [Five] years prior to the date of issue of the quotation notice, or,

- 17. During scrutiny, if it comes to the notice to the quotation inviting authority that the credential(s) and/or any other paper(s) of any bidder/quotationer has/have been found incorrect/manufactured/fabricated, that bidder will not be allowed to participate in the bid and penal action may be initiated by the department against the bidder along with rejection of his bid. - 18. - 19. - 22 Intending quotationers are required to submit online self attested photocopies of valid partnership deed (in case of partnership firm), current PTCC, PAN Card, GST, ITR, trade license, credentials.
- 23 All intending quotationers are requested to be present during online opening of bids/quotations positively, if considered necessary, instant offline bid may be conducted immediately after opening of bids to lower down rates and in no case his/their absence will stand against holding the same.
- 24 The successful quotationer (contractor/agency) will have to execute an Agreement in WBF No. 2911(i) as applicable in duplicate and 1(one) copy in plain paper along with other documents within seven (7) days from the date of issue of letter of acceptance, failing which the quotation is liable to be cancelled & earnest money will be forfeited to Govt.
- 25 No work shall be commenced or liability incurred until the work-order issued.
- 26 The acceptance of the quotation will rest with the Executive Engineer, New Town Construction Division-II, Housing Directorate who does not bind himself to accept the lowest quotation & reserve the authority to reject any or all the quotations received without assigning any reasons.
- 27 If any quotationer/bidder withdraws his offer before acceptance or refuse within a reasonable time without giving any satisfactory explanation for such withdrawals, he shall be disqualified for submitting quotation to this department for minimum period of one (1) year.
- 28 Successful quotationer/bidder will be required to obtain valid Registration Certificate & Labour Licence from respective Regional Labour offices where construction work by them are proposed to be carried out as per clause u/s 7 of West Bengal Building & other Construction Works' Act, 1996 and u/s 12 of Contract Labour Act as applicable.
- 29 Power of attorney holders are not allowed to sign Tender Document unless or otherwise approved by the Government.
- 30 Successful quotationer will be required (As applicable) to observe the conditions strictly:-
- i) Employees' Provident and Miscellaneous Provision Act, 1952 and Employee State Insurance Act. 1948 should be strictly adhered to whenever such Acts become applicable.
- ii) Minimum wages to the workers shall be paid according to the rates notified and/or revised by the State Government from time to time under the Minimum wages Act, 1948 in respect of scheduled employments within the time as per law. Payment, wherever applicable has to be made.
- iii) Adequate safety and welfare measures must be provided as per provisions of the building and other Construction Workers' (regulation of employment & conditions of service) Act, 1996 read with West Bengal Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Rules, 2004.
- All liabilities arising out of engagement of workers are duly met before submission of bills for payment. If there is any violation of any or all the relevant above criteria during execution of the job, it will render the concerned contractor/bidder ineligible for the work then and there or any subsequent stage as may be found convenient.
- 31 The quotation documents & other relevant particulars (if any) may be seen by the intending quotationers during office hours in the office of the Executive Engineer, New Town Construction Division-II, Housing Directorate, on all working days (except Saturday and Sunday and any other Govt. Holidays)
- 32 No joint venture is allowed.
- 33 Eligibility criteria for participation in the Quotation:-

Intending quotationers will have to satisfy the Executive Engineer, New Town Construction Division-II, Housing Directorate, about their capability & resourcefulness to complete such works within the scheduled time with their ITR, PAN, GST, PTCC, Trade License, as applicable while applying online to be technically qualified. The intending quotationers while applying for Quotation shall have to furnish a list of works of similar nature & magnitude executed by them during the last five (5) years with necessary satisfactory completion certificate under the authority of State/Central Government as well as State/Central Government undertaking, Statutory Bodies constituting under this stature of State/Central government (non-statutory documents). In absence of the above details quotation will be rejected.

For applicant as of Registered Unemployed Engineers Co-operative Societies / Registered Labour Co operative Societies audited balance sheet showing accounts upto previous last 5(five) years, ARCS, Bye law, eligible list of Registered Unemployed Engineers / Registered Labour Co operative Societies etc., as applicable must be documented through e-filling.

No conditional/incomplete quotations will be entertained.
- 35 The successful quotationer (contractor/agency) shall have binding with the terms & conditions and special terms & conditions of this e NIQ and with attached sheets.
- 36 Selected contractor should engage personnel having public interaction skill, effective verbal and listening communication skills. The personnel should possess cultural awareness and sensitivity and be flexible
- 37 Selected contractor & his personnel must be conversant with legal regulations and safety issues and the contractor must ensure that safety standards and buildings regulations are met.
- 38 Selected contractor should ensure that none of his personnel stays at site beyond duty hours unless otherwise instructed by site engineers.
- 39 Selected contractor will have to submit to the care taker, JE concerned, AE concerned and Executive Engineer the list of personnel with their photo, photo identity proof, address proof, licence duly attested by the person concerned and by the contractor.
- 40 Selected contractor shall take all possible care for Govt. property & of any damages due to negligence of his workers, the contractor/Agency shall be responsible for all such damages & repair the same at his own cost.
- 41 Intending quotationers should quote their rate only for service charges considering service as per terms & conditions and special terms & conditions including cost of materials to render such services and also considering that all tools & plants will have to be arranged by the contractor.

- 45 For any unsatisfactory performance of any personnel, the contractor will be responsible.
- 46 The selected contractor shall submit bill to the Executive Engineer through the concerned Assistant Engineer for payment.
- 47 Statuary deductions as per Govt. Rules and regulations and 0.99% of labour welfare cess & 0.01 % of revenue will be deducted from contractor's bill.
- 48 The contract may be terminated by giving one month notice on either side & on this event, no claim for idle labour etc. shall be entertained.
- 49 Arbitrations will not be allowed for the work. The clause 25 of 2911(ii) is to be considered as deleted clause, vide gazette notification no.-558/SPW-13th December, 2011.
- 50 If the selected agency executes the work satisfactorily, the agreement may be extended further, for another 6 (six) months or till selection of new agency as per existing terms & conditions of the agreement. The defect liability period for the work shall be treated 3 (three) months from the date of completion of work, security deposit for the work in this quotation is deducted as per latest G.O & to be deducted from the payment of the contractor. Such security deposit deducted from the payment of the contractor shall become payable as per latest Government G.O provision in W.B from No:-2911, so far as they relate to time framed for released of said, security deposit are to be treated as superseded by this provision.

- 51 The rate should be quoted in figures for each Security Personnel for duty of 8 (eight), hours per day including all charges like: Minimum Wages, EPF, ESI, Bonus, Service Tax, G.S.T applicable or calculated as per latest Order of the Labour Department, Government of West Bengal.
